#### TAX LEVY ORDINANCE

#### ROAD DISTRICT

#### **ORDINANCE NO. 2014-24**

An ordinance levying taxes for all road purposes for Aurora Township Road District, Kane County, Illinois, for the tax year 2014, collectable in 2015.

BE IT ORDAINED by the Board of Trustees of Aurora Township, Kane County, Illinois, as follows:

SECTION 1: That the Highway Commissioner of Aurora Township Road District on November 13, 2014 does hereby determine and declare that the sum of One Million Seven Hundred Eighty-four Thousand Two Hundred Ninety-two Dollars (\$1,784,292.00) are hereby levied upon all property subject to taxation within the Road District as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Road District as required by statute or voted by the people in accordance with the law, for such purposes as:

General Road Fund, Illinois Municipal Retirement Fund,

Social Security Fund, Insurance Fund,

Equipment and Building Fund, Bridge-Joint Construction with County Fund

for the year 2014.
