- I. CALL TO ORDER

  ROLL CALL AND ESTABLISH QUORUM
- II. A meeting of the Aurora Township Board of Trustees was held at the Aurora Township offices, 80 North Broadway, Aurora, Illinois at 4 p.m. on Thursday, July 23, 2015. Notice was sent to all members of the board as required by statute.
- III. Aurora Township Supervisor Bill Catching called the meeting to order at 4 p.m. Supervisor Catching led the group in the Pledge of Allegiance. Trustee Dolores Hicks gave the Invocation.
- IV. Aurora Township Clerk Ken Christy called the roll with the following Board of Trustees members present: Bill Catching Supervisor, Trustees David Moore, Dolores Hicks, Juanita Wells, and Juan Reyna. Assessor Davis Offutt and Highway Commissioner John Shoemaker were excused absences. Staff and public present as attached.
- V. Approval of the minutes of the Regular Board Meeting of July 9, 2015 was made by Supervisor Catching and seconded by Trustee Reyna. The motion passed unanimously by voice vote.
- VI. Approval and/ or Audit of Township and Road District bills:
- a. Motion to approve Town Fund Bills in the amount of \$51,598.80 was made by Supervisor Catching and seconded by Trustee Moore. The motion passed unanimously by voice vote.
- b. Motion to approve Road & Bridge Fund bills in the amount of \$31,158.01 was made by Supervisor Catching and seconded by Trustee Wells. The motion passed unanimously by voice vote.
- c. Motion to approve General Assistance Fund bills in the amount of \$2,992.99 was made by Supervisor Catching and seconded by Trustee Hicks. The motion passed unanimously by voice vote.
- d. Motion to approve Mental Health Fund bills in the amount of \$22,231.27 was made by Supervisor Catching and seconded by Trustee Reyna. The motion passed unanimously by voice vote.

- e. Combined motion to approve IMRF and Road and Bridge IMRF Fund bills in the amount of \$10,594.91, was made by Supervisor Catching and seconded by Trustee Moore. The motion passed unanimously by voice vote.
- f. Combined motion to approve Social Security and Road and Bridge Social Security Fund bills in the amount of \$6,341.67, was made by Supervisor Catching and seconded by Trustee Wells. The motion passed unanimously by voice vote.

## VII. REPORTS

- a. Assessor's Report by Davis Offutt Report Attached Summary: The Equalization Factor for Aurora Township for the 2015 tax year is 1.0881. This means that the valuations submitted by the Aurora Township Assessor's Office will be increased by that factor.
- b. Highway Commissioner's Report by Jason Owens Attached Summary Drain project on Barston Lane done, lacking only landscaping. Lawn Mowing for Seniors is ongoing. The Commissioner will be attending the Green Fleet seminar on July 20 to learn of new and available technologies to help make Township trucks easier on the environment.
- c. Supervisor Report by Supervisor Bill Catching Supervisor Catching reported he attended the public hearing on Pace services. Pace is reconfiguring some routes and adding Call-And-Ride services on the southeast area of the township. The Township website was down briefly but is up on a new server. Catching said he is also working on getting out more information on social media including Facebook and Twitter. Catching and the code enforcement officers met with County representatives to improve coordination on code enforcement and zoning issues. The County has a new database to identify vacant properties, which have been a problem due to the tremendous increase in foreclosures.
- d. Code Enforcement Officer's Report by Clarence Robinson Violation report attached –Report was reviewed with the Board.
- e. General Assistance Manager's Report Attached Summary: Report described new clients. Senior Services Kane County Cougars event. August 11<sup>th</sup> is the TRIAD picnic at Phillips Park. Senior Services committee will be meeting on July 24. At the August meeting State Representative Mike Fortner will be speaking.
- f. June 2015 Financial Statement Review By Chief Of Staff Patricia Richardson Summary: Ms. Richardson reviewed with the Board the June financials. She also reviewed Township investments with the Board.
