

**ORDINANCE No. 2016-03
AMENDED APPROPRIATION ORDINANCE
AURORA TOWNSHIP ROAD DISTRICT**

A SUPPLEMENTAL BUDGET AND APPROPRIATION ORDINANCE AMENDING THE AURORA TOWNSHIP ROAD DISTRICT BUDGET FOR AURORA TOWNSHIP, KANE COUNTY, ILLINOIS, FOR THE FISCAL YEAR BEGINNING APRIL 1, 2015, AND ENDING MARCH 31, 2016

WHEREAS, Aurora Township Road District is a unit of local government organized and existing pursuant to the Township Code as set forth in 60 ILCS 1/1-1 et seq; and

WHEREAS, pursuant to 60 ILCS 1/80-60 the annual budget and appropriation ordinance is prepared in accordance with the Illinois Municipal Budget Law 50 ILCS 330 et seq; and

WHEREAS, pursuant to 50 ILCS 330/3 of the Illinois Municipal Budget Law the Aurora Township Board of Trustees previously adopted the annual budget and appropriation ordinance for the Aurora Township Road District (Ordinance 2015-18) for the period April 1, 2015 to March 31, 2016, on May 14, 2015; and

WHEREAS, sufficient resources exist in the Aurora Township Road District Funds to cover the amended budget; and

WHEREAS, the Township Board is authorized pursuant to the Illinois Municipal Budget Law 50 ILCS 330/3 to amend the budget; and

WHEREAS, the purpose of the budget amendment is to provide for operating expenditures during the fiscal year ending March 31, 2016.

NOW THEREFORE, BE IT ORDAINED by the Board of Trustees of Aurora Township, Kane County, Illinois:

SECTION 1: Aurora Township Road District Budget for the year April 1, 2015 to March 31, 2016 is hereby amended in accordance with the schedule attached hereto and made a part hereof referred to as Exhibit A showing amended expenditures of \$1,767,535.50.

SECTION 2: That all ordinances and parts thereof in conflict herewith are expressly repealed and are of no affect.

SECTION 3: That repeal of any ordinance by this Ordinance shall not affect any rights accrued or liability incurred under said repealed ordinance to the effective date hereof. The provisions of this Ordinance, insofar as they are the same or substantially the same as those of any prior ordinance, shall be construed as a continuation of said prior ordinance.

SECTION 4: That it is the intention of the Board of Trustees of Aurora Township that this Ordinance and every provision thereof shall be considered separable, and the validity of any section, clause or provision of the Ordinance shall not affect the validity of any other portion of this Ordinance.

SECTION 5: That the Board of Trustees of Aurora Township finds that the subject matter of this Ordinance pertains to the government and affairs of Aurora Township Road District and is passed pursuant to the Township Code and the Illinois Municipal Budget Law.

SECTION 6: That this Ordinance shall be known as Ordinance No. 2016-03 of Aurora Township, Illinois and shall be in full force and effect from and after its passage and approval.

SECTION 7: That a certified copy of the Amended Appropriation Ordinance must be filed with the County Clerk within 30 days after adoption.
