An ordinance levying taxes for all town purposes for Aurora Township, Kane County, Illinois, for the tax year 2016, collectable in 2017.

BE IT ORDAINED by the Board of Trustees of Aurora Township, Kane County, Illinois, as follows:

SECTION 1: That the sum of Four Million Twenty-nine Thousand Seven Hundred Seventy-five Dollars (\$ 4,029,775.00) are hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as:

General Town Fund,

Illinois Municipal Retirement Fund,

Mental Health Fund,

General Assistance Fund,

Social Security Fund

for the year 2016.

SECTION 2: That the amount levied for each object and purpose shall be as follows:



SECTION 5: That this ordinance shall be in full force and effect after its adoption, as provided by law.



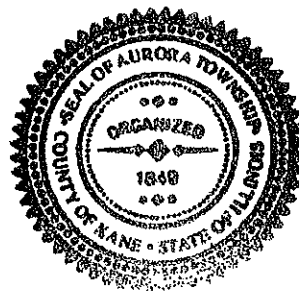
