

TAX LEVY ORDINANCE

TOWNSHIP

ORDINANCE No. 2017-31

An ordinance levying taxes for all town purposes for Aurora Township, Kane County, Illinois, for the tax year 2017 , collectable in 2018.

BE IT ORDAINED by the Board of Trustees of Aurora Township, Kane County, Illinois, as follows:

SECTION 1: That the sum of Four Million One Hundred Sixty-One Thousand Two Hundred and Nine Dollars (\$4,161,209.00) are hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as:

Illinois Municipal Retirement Fund

Mental Health Fund,

General Assistance Fund

Social Security Fund
