

Broadway, Aurora, Illinois. In April 2020, the first regular meeting will be held on Tuesday, April 14, 2020, at 5:00 p.m. at the Aurora Township Youth and Community Center, 313 Gale Street, Aurora, Illinois, and the second regular meeting will be held on Thursday, April 30, 2020 at 4:00 p.m. at the Aurora Township main office. In November 2020, the second regular meeting will be held on Tuesday, November 24, 2020, at 4:00 p.m. In December 2020, the second regular meeting will be held on Tuesday, December 22, 2020.

**IT IS FURTHER HEREBY RESOLVED THAT** the Township Clerk shall cause notice of the above times and places of the regular meetings to be published in *The Aurora Beacon News* during the first week of January 2020. The Clerk shall also comply with Section 2.02 by posting a copy of said notice at the township's main office, and mailing or faxing copies of the notice and schedule to any news medium that has filed a request for such notice.


