A meeting of the Aurora Township Board of Trustees was held at the Aurora Township office, 80 North Broadway, Aurora, IL, at 4 p.m. on Thursday, September 8, 2016. Notice was sent to all members of the Board as required by statute.

Aurora Township Supervisor Bill Catching called the meeting to order at 4:00 p.m. Supervisor Catching led the group in the Pledge of Allegiance. Trustee Hicks gave the invocation.

Aurora Township Clerk Jason Owens called the roll with the following Board of Trustees members present: Bill Catching – Supervisor; Trustees: Dolores Hicks, David Moore, Juan Reyna, Juanita Wells.

Clerk Jason Owens -- Present.

Assessor Davis Offutt - Present.

Highway Commissioner John Shoemaker - Present.

II. Motion to approve the minutes of the regular Board meeting held on August 25, 2016 made by Supervisor Catching, seconded by Trustee Reyna. Motion carried by unanimous voice vote.

III. Approval and/or Audit of Township and Road District Bills.

- a. Motion made by Supervisor Catching and seconded by Trustee Hicks to approve the Town Fund bills in the amount of \$80,340.43. Motion passed by unanimous voice vote.
- b. Motion made by Supervisor Catching and seconded by Trustee Moore to approve the Road & Bridge Fund bills in the amount of \$13,998.49. Motion passed by unanimous voice vote.
- c. Motion made by Supervisor Catching and seconded by Trustee Wells to approve the General Assistance Fund bills in the amount of \$5,736.02. Motion passed by unanimous voice vote.
- d. Motion made by Supervisor Catching and seconded by Trustee Reyna to approve the Mental Health Fund bills in the amount of \$366,080.79. Motion passed by unanimous voice vote.
- e. Motion made by Supervisor Catching and seconded by Trustee Hicks to approve the Equipment & Building Fund bills in the amount of \$1,605.00. Motion passed by unanimous voice vote.
- f. Motion made by Supervisor Catching and seconded by Trustee Moore to approve the combined IMRF and Road & Bridge IMRF Funds bills in the amount of \$11,437.06.
 Motion passed by unanimous voice vote.
- g. Motion made by Supervisor Catching and seconded by Trustee Wells to approve the combined Social Security and Road & Bridge Social Security bills in the amount of \$5,426.79. Motion passed by unanimous voice vote.

IV. Reports

- a. Assessor's Report Report attached. Summary: Assessor Offutt reported that 75 Board of Review filings were made, but he expects more to follow as the County hasn't processed most of the requests yet.
- b. Highway Commissioner's Report John Shoemaker. Summary: Commissioner Shoemaker reported that work began on the Sartor Avenue drainage project which will move the water away from the homes on the west side of Sartor to the east side where no homes exist. Shoemaker mentioned an issue with one of the lawn service residents that was serious enough to bring to the Board's attention. Clerk Owens explained that the resident was taking videos of the lawn crew (after being asked to stop) and had made several remarks that were insensitive to the crew members. Shoemaker mentioned that the Board creates the list, so he can't remove anyone. The trustees were all in agreement that the resident should be removed immediately from the list. Supervisor Catching said he would send out a letter to the resident informing him of the Board's decision.
- c. Supervisor's Report Bill Catching. Summary: Supervisor Catching reported that he is working on gathering quotes for tree removal on the 200 block of Ohio. Catching also reported that Critical Key submitted a CDAP loan application. He will set up a CDAP

loan committee meeting for next week. Catching said he knows several of the parties involved on both sides of the transaction, so he will likely recuse himself from serving on the review committee. Catching reported that Vanessa Aguirre, a commercial lender from Old Second National Bank, has reviewed the application and is prepared to make a recommendation to the review committee.

- d. Ride in Kane Manager's Report Melissa Wilmot. Report attached. Summary: Ms. Wilmot reported that August was a slow month. Ms. Wilmot also reported that there were a couple of incidents of verbal abuse of the drivers by riders. The RIK office is sending out letters to these residents to inform them of the consequences of continued misconduct. Ms. Wilmot also reported that there were several instances of PACE reassigning Aurora Township rides to non-AT service providers after daily routes had been planned. Wilmot and Semmler have contact PACE about this practice. Finally, Ms. Wilmot reported that driver phones would need to be upgraded soon due to a Verizon Wireless update to its Push-to-Talk network. Supervisor Catching reported that he attended the quarterly meeting for the RIK stakeholders and AID staff will send on monthly reports of activity at the start of each month. PACE typically provides these reports about three months later.
- e. Youth Services Director's Report Scot Thurman. Report attached. Summary: Mr. Thurman reported that the United Way Cardboard Boat Race event went well and, while the boat didn't sink, it didn't move very far either. Mr. Thurman said he and the staff are getting ready for the beginning of fall after-school programs. He also reported that the soccer tournament held over Labor Day weekend was a success. Trustee Wells asked how the summer meal program fared. Mr. Thurman said that he thought it went well, with very few issues with the food or deliveries. Mr. Thurman anticipates having most of the remaining summer lunch reimbursement requests submitted to the State of IL by the next Board of Trustees meeting.
