MINUTES OF THURSDAY, JANUARY 10, 2008 BOARD OF TRUSTEES MEETING

I. Township Supervisor James Murphy called the meeting to order at 4:00pm. He then led the Board in the Pledge of Allegiance. The following Board of Trustees members were present: Annie Craig, Christina Campos, and John Shoemaker, Dr. Monica Silva. Also present: Highway Commissioner Fred Burgess and Assessor Davis Offut. **Staff Present**: Frank Paull, Carol VanHooser, Ismael Espiricueta, and Clarence Robinson.

II. APPROVAL OF THE MINUTES OF THE BOARD OF TRUSEES MEETING ON DECEMBER 27, 2007.

1. There was a motion by Trustee Craig and seconded by Trustee Shoemaker to approve the Board of Trustee regular meeting minutes as amended from December 27, 2007. Motion carried by voice vote.

III. APPROVAL AND/OR AUDIT OF TOWNSHIP AND ROAD DISTRICT BILLS

- 1. There was a motion by Trustee Craig and seconded by Trustee Shoemaker to approve Town bills in the amount of \$43, 056.32. After a discussion for clarification of certain line items, motion carried by voice vote.
- 2. There was a motion by Trustee Shoemaker and seconded by Trustee Craig to audit Road & Bridge bills of \$17,564.42. Motion carried by voice vote.
- 3. There was a motion by Trustee Craig and seconded by Trustee Silva to audit General Assistance bills of \$11,762.81. Motion carried by voice vote.
- 4. There was a motion by Trustee Silva and seconded by Trustee Craig to audit and approve Township Payroll bills. These bills include IMRF: \$5,850.78; SOCIAL SECCURITY \$4,276.45; R & B SOCIAL SECURITY 901.80; R & B IMRF \$1,368.18. Motion carried by voice vote.

- 5. There was a motion by Trustee Shoemaker and seconded by Trustee Craig to approve **CDAP** bills of **\$1,604.64** Motion carried by voice vote.
- 6. There was a motion by Trustee Shoemaker and seconded by Trustee Craig to audit **JOINT BRIDGE** bills of \$30,605.00 Motion carried by voice vote.

IV. REPORTS

- 1. Assessor Davis Offut submitted a written report including his 2008 budget proposal that includes a 2.41% increase from last year. He stated that within Aurora Township property values increased 6.62% in 2007. He also explained the complaint process for property tax valuation within Kane County.
- 2. Highway Commissioner Burgess reported on the repairs on the guardrail on Loucks Ave. He noted that these repairs are not reimbursable because the guardrails are not connected to a bridge. The invoices for these repairs were mailed to the residents involved. All stop signs have been repaired. Repairs are needed on several trucks because of leaks.
- 3. The Youth Department Director, Ismael Espiricueta, submitted a written report and highlighted the volley ball league that is starting for 4th grade girls and a chess competition.
