# MINUTES OF THURSDAY, MARCH 14, 2013 BOARD OF TRUSTEES MEETING

- I. Township Supervisor Christina Campos called the meeting to order at 4:02pm and lead the Board in the Pledge of Allegiance. The following Board of Trustees members were present: Bill Catching, Dave Moore, and Mark Semmler. Also present: Highway Commissioner John Shoemaker and Assessor Davis Offutt. - II. Supervisor Campos read a proclamation thanking Jo Fredell Higgins and Paul Paticoski for their 16 years of service on the Aurora Township Youth Commission and presented the proclamation to them.

# III. APPROVAL OF THE MINUTES OF THE BOARD OF TRUSEES MEETINGS ON FEBRUARY 14 & 28, 2013.

- 1. There was a motion by Supervisor Campos and seconded by Trustee Catching to approve the Board of Trustee regular meeting minutes from February 14, 2013 as amended. Motion carried by voice vote.
- 2. There was a motion by Supervisor Campos and seconded by Trustee Catching to approve the Board of Trustee regular meeting minutes from February 28, 2013 as amended. Motion carried by voice vote.

# IV. APPROVAL AND/OR AUDIT OF TOWNSHIP AND ROAD DISTRICT BILLS

- 1. There was a motion by Supervisor Campos and seconded by Trustee Moore to reduce the Assessor's bills by \$25.00. Motion passed by voice vote.
- 2. There was a motion by Trustee Catching and seconded by Trustee Moore to approve the **Town Bills** in the amount of \$44,327.68. Motion passed by voice vote.

- 3. There was a motion by Supervisor Campos and seconded by Trustee Semmler to approve **Road District Bills** in the amount of \$27,585.27. Motion passed by voice vote.
- 4. There was a motion by Supervisor Campos and seconded by Trustee Moore to approve **General Assistance Bills** of \$17,330.89. Motion passed by voice vote.
- 5. There was a motion by Supervisor Campos and seconded by Trustee Moore to audit and approve Township Payroll bills. These bills include IMRF: \$8,367.60 and SOCIAL SECURITY \$4,606.99 Motion carried by voice vote.
- 6. There was a motion by Supervisor Campos and seconded by Trustee Catching to audit and approve Road & Bridge Payroll bills. R & B SOCIAL SECURITY \$1,241.42; R & B IMRF \$2,489.66. Motion carried by voice vote.
- 7. There was a motion by Supervisor Campos and seconded by Trustee Moore to approve the **Road & Bridge Building & Equipment Fund** of \$2,500.00. Motion passed by voice vote.

- 1. Assessor Davis Offutt submitted a written report, and announced that the 2013 assessment revaluing has started, (see attached).
- 2. Highway Commissioner Shoemaker reported that his department is working to stay ahead of patching. He asked that people inform his office of any potholes that need to be filled.
- 3. Vicki Marques submitted a written Youth Department report (see attached) and highlighted certain items in her report: she thanked Michael Isaacson from the Kane County Health Department for helping the Township secure two grants for the Fit for Kids Initiative; she is working to plan the Spring and Summer Basketball programs; upgrades in the computer system are still needed in the Youth Department; work on the Youth Department roof will start on Monday, March 18<sup>th</sup>.

### V. UNFINISHED BUSINESS

There was a motion by Supervisor Campos and seconded by Trustee Moore to place in FY Budget 2014 the item of IT Upgrades with no specific dollar amount. After a lengthy discussion, the motion passed by voice vote.

#### VI. NEW BUSINESS

There was a motion by Supervisor Campos and seconded by Trustee Moore to approve the hiring request for seasonal workers for the spring/summer of 2013. Motion passed by voice vote.
