## 2. Highway Commissioner, John Shoemaker

Mr. Shoemaker reported the purchase of a new trailer with an explanation therefore.

Mr. Shoemaker reported that the initiation of the mowing program should start on May, 28, 2010 and should take approximately two weeks to complete with the assistance of a new mower.

Mr. Shoemaker stated that concrete pouring was to take place on June 16, June 17, 2010.

Mr. Shoemaker also reported that a \$50,000.00 contract for one garden storm contract was executed from the State and place on hold. September 2010 was projected as the start date.

Mr. Shoemaker reported that treatment for mosquitoes was on target and probably ahead of schedule.

## 3. Sheriff's Report

Sgt Dave Wolf stated that he was taking over for Lt. Stutz, and announced that 2 remaining personal were on duty.

Sgt Wolf stated the new implementation of block captains meetings to begin every other month for neighborhood watchers.

Sgt Wolf also stated that a joint effort warrant sweep by the Park District, Aurora and No. Aurora PD's for gang members sought on outstanding warrants was going okay. There was one arrest coming from the Mocherville area

### VII. NEW BUSINESS

Presentation by Jerry Murphy, Executive Director, Mental Health and Mental Retardation Services.

Mr. Murphy provided brochures outlining funded agencies providing assistance for mental health, developmental disability and substance abuse needs. Mr. Murphy stated that the Mental Health Board (and tax levy) was established approximately 40 years ago by referendum and provided a partnership for services involving 7 townships including Aurora.

Mr. Murphy stated that the "708" board representation should be by terms and be composed of Trustee Members as well.

Mr. Murphy stated that the 7 Township boards set up services as a notfor-profit corporation to administer services for those in need. The INC. board meets 6 times per year. Notices with agendas will be sent in advance of the meetings. Mr. Murphy explained the funding of the agencies and the funds usage. (See attached Aurora Township Mental Health Levy and Service Statistics).

Mr. Murphy also explained that the Board had ownership of approximately 12-13 acres with building rental space available to agencies delivering services at approximately .30 on the dollar.

The Board is not concerned with making a profit as much as is providing affordable services. Building up keep and maintenance was also explained. Mr. Murphy explained the operating budget at 12 percent and presented statistics on services delivered covering a period of 9 years from 1990 -2009. See attached statistics.

Trustee Hicks acknowledged the need for services as provided by the Mental Health Board as she previously worked as a nurse at Mercyville and was familiar with that need through her past experiences, as well as her knowledge that past facilities have closed.

Supervisor Pro Tem Moore Thanked Mr. Murphy for his report and also acknowledged that the mission of the Mental Health Board was a noble one and appreciated their existence since 1970
