## MINUTES OF THURSDAY, MAY 28, 2009 BOARD OF TRUSTEES MEETING

## II. APPROVAL OF THE MINUTES OF THE BOARD OF TRUSEES MEETING ON MAY 14, 2009.

1. There was a motion by Trustee Catching and seconded by Trustee Moore to approve the Board of Trustee regular meeting minutes from May 14, 2009 as amended. Motion carried by voice vote.

PACE Representative and Mayor of Batavia Jeffery Schielke presented Aurora Township with a check for $\$ 104,400.00$ for its transportation services.

2. Highway Commissioner Shoemaker toured the Township with the Water Resources Department to inspect drainage problems; he submitted these projects for funding through the state's capital bill; he is working to "go-green" in his department.
3. Clarence Robinson reported that Highway Commissioner Shoemaker has agreed to move the soccer field; the summer lunch program which starts June $8^{\text {th }}$.

Supervisor Campos gave a detailed explanation for his 2009-10 proposed Town budget. The Town budget will be on display for 30 days at the Township office.

There was a motion by Trustee Silva and seconded by Trustee Moore to approve the 2009-10 Town Fund and 2009-10 Road \& Bridge Fund. Motion
carried by voice vote. Both budgets will be on public display for 30 days for public inspection.
