MINUTES OF THURSDAY, AUGUST 27, 2009 BOARD OF TRUSTEES MEETING

I. Township Supervisor Christina Campos called the meeting to order at 4:00pm and then asked Clerk Thomas to lead the Board in the Pledge of Allegiance. II. APPROVAL OF THE MINUTES OF THE BOARD OF TRUSEES MEETING ON AUGUST 13, 2009.

1. There was a motion by Trustee Catching and seconded by Trustee Moore to approve the Board of Trustee regular meeting minutes from August 13, 2009 as amended. Motion carried by voice vote.

III. APPROVAL AND/OR AUDIT OF TOWNSHIP AND ROAD DISTRICT BILLS

- 1. There was a motion by Trustee Moore and seconded by Trustee Hicks to remove the invoice related to the law firm of Hogan Marren for 3,835.00 from the list of bills to be approved until the September 24th Board of Trustee meeting. Motion passed by voice vote.
