#### **MINUTES**

#### I. CALL TO ORDER

#### PLEDGE OF ALLEGIANCE - INVOCATION - ROLL CALL AND ESTABLISH QUORUM

A meeting of the Aurora Township Board of Trustees was held at the Aurora Township Office, 80 North Broadway, Aurora, Ill., at 4 p.m. Thursday September 11, 2014. Notice was sent to all board members as required by state statute.

Aurora Township Supervisor William Catching called the meeting to order at 4 p.m. Supervisor Catching led the group in the Pledge of Allegiance. Trustee Dolores Hicks gave the Invocation. A moment of silence was held in remembrance of 9/11.

Aurora Township Clerk Ken Christy called the roll with the following board members present: Supervisor Catching, Trustees Dolores Hicks, David Moore, Juanita Wells and Juan Reyna.

Also present were Assessor Davis Offutt and Highway Commissioner John Shoemaker. Staff and public present are listed in the attached sign-in sheet.

II. APPROVAL OF MINUTES - Motion to approve the minutes of the regular board meeting on Aug. 28, 2014, made by Supervisor Catching, seconded by Trustee Hicks. Motion passed unanimously by voice vote.

#### III. APPROVAL OF BILLS

- 1. Motion made by Supervisor Catching and seconded by Trustee Hicks, to approve the Town bills in the amount of \$77,046.47. Motion passed unanimously by voice vote.
- 2. Motion made by Supervisor Catching and seconded by Trustee Moore, to approve Road District bills in the amount of \$11,653.75. Motion passed unanimously by voice vote.
- 3. Motion made by Supervisor Catching and seconded by Trustee Hicks to approve General Assistance bills in the amount of \$1,859.39. Motion passed unanimously by voice vote.
- 4. Motion made by Supervisor Catching to pay IMRF and Road and Bridge IMRF bills in the amount of \$10,687.43. Seconded by Trustee Moore. Motion passed unanimously by voice vote.

5. Combined motion by Supervisor Catching to approve Social Security and Road and Bridge Social Security bills of \$4,970.63. Seconded by Trustee Hicks. Motion passed unanimously by voice vote.

#### **IV. REPORTS**

- **A.** Assessor's Report A written report submitted by Davis Offutt is attached. In summary, his office is very busy with the final appeal date for review assessments approaching September 18<sup>th</sup>. To date, we have 30 appeals. Assessor Offutt led a discussion when each Township has to file equalization factors to the County. He also shared the parcel count and assessed values for each Township from 2003-2013.
- B. **Highway Commissioner's Report** John Shoemaker reported the data collection of all roads and utilities in the Township right of ways has begun. Commissioner reports he will use a stringer employee to help in this and also to cover vacations. They are in the process of evaluating the new boom truck. The District has an option to select another vehicle if this one does not meet our needs. We are ready for winter. Salt will be delivered late October. Even through salt prices went way up, we had a two year contract. This resulted in only a 5% price increase. All equipment is ready for the winter season. Trustees Wells and Reyna complimented Commissioner Shoemaker and his staff for the great job they do in preparing and executing their duties.

Mr. Shoemaker also reported he was in an accident with Township vehicle. The other driver slid through an intersection and hit his vehicle. Shoemaker was not injured, the damage will be fixed.

- **C. Supervisor's Report** Supervisor Bill Catching shared with the Board a thank you note from Mary Gaworski for our lawn mowing services. He further reported that he and Chief of Staff Patricia Richardson, reviewed the six-month financials and we look good, except that lawn mowing program was a little more due to a rainy summer, which required more lawn mowing than anticipated. Catching also shared the job description for the potential hiring of a new human resources coordinator. He will post the opening on the Township website and also the Career Builder website. He further reported that he attended a Township Supervisors' meeting in St. Charles, II.
- D. Ride-in-Kane Manager's Report A ridership report was shared with Board and is attached. RIK Manager Melissa Franks reported on the quarterly sponsors meeting with PACE. Ridership has been down, but it has been down in other Townships also. Our Sugar Grove program so far has had only one client. We will only be in Sugar Grove on Tuesdays and Thursdays as needed. We are still waiting on new buses, which will save us money on fuel costs (approximately \$40,000 a year). We tried to get an extra bus, but PACE denied our request to expand the fleet. She reported that staff is reviewing our waiting list and calling potential clients. She and Supervisor Catching are working on the ridership report to better reflect our operations as a provider and our contributions as a Ride-in-Kane sponsor.
- **E. Youth Services Director's Report** Youth Center Director Scot Thurman's report is attached. In summary, Mr. Thurman reviewed the following programs with updates and future programs with the board:
  - 1.) Summer Lunch Program ended August 15<sup>th</sup>.
  - 2.) Soccer Programs Summer ended with 34 teams competing. Indoor soccer will be starting at the end of October.

- 3.) 83 people are currently in the Community Service Program so far 6 have completed the program.
- 4.) Transportation meeting results will be updated at next Township meeting.
- 5.) Received a \$2,000.00 grant from Target to purchase lap top computers.
- 6.) New metal detector has been installed at Youth Center.
- 7.) The Youth Center will be in the Fiesta Patrias Parade this Sunday, September 14<sup>th</sup>. All are invited to participate.

Trustee Reyna asked if we track the number of Youth participating in our programs monthly. Scot will look into adding this info for Board into his report. Trustee Wells also suggested a possible program to help the youth with financial planning.

**V. UNFINISHED BUSINESS** – Trustee Reyna asked for an update on the former sheriff's substation on Farnsworth Avenue. Supervisor Catching reported we have been waiting for a response.

VI. NEW BUSINESS - None

VIII. ANNOUNCEMENTS — Ms. Richardson reminded the board that the Township Officials of Illinois meeting will be held in November in Springfield and reservations are due by the next board meeting. Supervisor Catching reported that Melissa Franks is getting married September 26. He and the rest of the board offered their best wishes. Catching also reported that he forgot to mention earlier that Clarence Robinson and Juvenal Jaquez did a great job of landscaping around the Township building. Finally, Catching reminded the board of the Hispanic Pioneers breakfast held on September 12.

**IX. ADJOURNMENT** - Supervisor Catching made a motion, seconded by Trustee Hicks, to adjourn the meeting at 4:53 p.m. The motion passed unanimously by voice vote.
