- II. Approval of the minutes of the Regular Board Meeting of July 23, 2015 made by Supervisor Catching and seconded by Trustee Reyna. The motion carried by voice vote unanimously.

- A. Assessor's Report by Davis Offutt Report Attached Summary: The Equalization Factor for Aurora Township for 2015 tax year is 1.0881. This means that the Equalized Assessed Valuation submitted by the Aurora Township Assessor's Office have been increase by that factor. We are now responding to fillings from the Kane County Board of Review. An invoice for a new laptop was presented for approval today.
- B. Highway Commissioner's Report by John Shoemaker Working on landscaping. We are paving where needed plus replacing culverts where needed. The Highway Department repaired the sink holes on Oakview Ave. and in Moecherville. Lawn mowing is up to date for all properties that are in our Senior Mowing Service. Next we will finally close the transfer of the McClure Road.
- C. Supervisor Report by Supervisor Bill Catching Supervisor Catching stated that this week the Township parking lot was used to help display equipment for the Emergency Vehicle show. On Tuesday of this week, Supervisor Catching re-signed the TRIAD Charter along with several Police Chiefs from this area. The National Night Out event was a great success. There were 20 sites around Town.

The Township web site will now feature a calendar with all Township Events posted.

In attendance were two County Sheriffs' Officers and a Dispatcher from the County to address illegal parking in the Township. We thanked them for their explanations.

- D. Ride-In-Kane Manager's Report by Melissa Wilmot Ridership summary attached. There have been three new part time drivers hired for Ride-In-Kane Program. Ridership is up in the program. Old buses are still being stored at the Road Commissioner's office. Still awaiting their return to Pace.

He addressed the following areas –The Soccer Programs, The Basketball Programs, After-school Programs, Community Service Program, Senior Activities and our Summer Camp program.
