A meeting of the Aurora Township Board of Trustees was held at the Aurora Township office, 80 North Broadway, Aurora, IL, at 4 p.m. on Thursday, March 24, 2016. Notice was sent to all members of the Board as required by statute.

Aurora Township Supervisor, Bill Catching, called the meeting to order at 4:00 p.m. Supervisor Catching led the group in the Pledge of Allegiance. Trustee Moore gave the invocation.

Aurora Township Deputy Clerk, Jason Owens, called the roll with the following Board of Trustees members present: Bill Catching – Supervisor; Trustees: David Moore and Juan Reyna. Delores Hicks and Juanita Wells – Excused Absent Clerk Ken Christy – Excused Absent Assessor Davis Offutt – Present.

Highway Commissioner John Shoemaker – Present.

II. Motion to approve the minutes of the regular Board meeting held on March 10, 2016 made by Supervisor Catching, seconded by Trustee Reyna. Motion carried by unanimous voice vote.

III. Approval and/or Audit of Township and Road District Bills.

- a. Motion made by Supervisor Catching and seconded by Trustee Moore to approve the Town Fund bills in the amount of \$49,402.59. Motion passed by unanimous voice vote.
- b. Motion made by Supervisor Catching and seconded by Trustee Reyna to approve the Road & Bridge Fund bills in the amount of \$19,898.56. Motion passed by unanimous voice vote.
- c. Motion made by Supervisor Catching and seconded by Trustee Moore to approve the General Assistance Fund bills in the amount of \$12,286.67. Motion passed by unanimous voice vote.
- d. Motion made by Supervisor Catching and seconded by Trustee Reyna to approve the Liability Insurance Fund bills in the amount of \$36,156.00. Motion passed by unanimous voice vote.
- e. Motion made by Supervisor Catching and seconded by Trustee Reyna to approve the Equipment & Building Fund bills in the amount of \$5,262.15. Motion passed by unanimous voice vote.
- f. Motion made by Supervisor Catching and seconded by Trustee Moore to approve the Joint Bridge Fund bills in the amount of \$59,953.50. Motion passed by unanimous voice vote.
- g. Motion made by Supervisor Catching and seconded by Trustee Reyna to approve the combined IMRF and Road & Bridge IMRF Funds bills in the amount of **\$27,441.10**. Motion passed by unanimous voice vote.
- h. Motion made by Supervisor Catching and seconded by Trustee Moore to approve the combined Social Security and Road & Bridge Social Security bills in the amount of \$6,426.99. Motion passed by unanimous voice vote.

IV. Reports

- a. **Assessor's Report** Report attached. Summary: Assessor Offutt reported that they have re-valued approximately 65% of Aurora Township.
- b. **Highway Commissioner's Report** John Shoemaker. Summary: Brush pick up will start the week of April 18. Just completed tree trimming program and now moving on to tree stump grinding. Watching drainage for any signs of flooding. Replaced the culvert at entrance of 220 Butterfield Road.
- c. **Supervisor's Report** Bill Catching. Summary: Supervisor Catching reported that the staff is busy with end of Fiscal Year assignments. He attended a TOI conference which discussed preparing for elections he said the importance of Township Clerk was highlighted. Glenn Poshard, former United States Representative from the 19th District, gave a very moving speech highlighting the importance of township government.

- d. **Code Enforcement Officer's Report** Supervisor Catching. Clarence is at his hours limit for the year and Danny is just back from vacation. No issues to report.
- e. General Assistance Manager's Report Suely Cabral. Report attached. Summary: Ms. Cabral reported that sixteen clients were re-approved for financial assistance with two new clients added and two clients terminated. Ms. Cabral also reported that seniors can have their taxes completed for free, by AARP volunteers, at the Senior Services office.
- **f. February Financial Statement Report** Patricia Richardson. Ms. Richardson reported that March will be more active, as it is the end of the Fiscal Year. She also stated that the Township is in good shape for the end of the year.

No public additions were offered during the discussion period. Motion passed by unanimous voice vote.
- Resolution 2016-05 Transfer of Appropriation Town Fund. Motion made by Supervisor Catching and seconded by Trustee Reyna to approve Resolution 2016-05 Transfer of Appropriation in the amount of \$10,586.00. Motion passed by unanimous voice vote.
- c. Resolution 2016-06 Transfer of Appropriation General Assistance Fund. Motion made by Supervisor Catching and seconded by Trustee Moore to approve Resolution 2016-06 Transfer of Appropriation in the amount of \$8,009.00. Motion passed by unanimous voice vote.
- d. Resolution 2016-07 Appointing Members to Aurora Township Community Mental Health 708 Board. Motion made by Supervisor Catching and seconded by Trustee Reyna to appoint Robert Borchert of 512 Simms Street, Aurora, II. to the Aurora Township Community Mental Health 708 Board. Supervisor Catching mentioned that Mr. Borchert is retired from A.I.D. and he confirmed with the board's executive director that Mr. Borchert's prior employment would not serve as a conflict of interest for this appointment. Motion passed by unanimous voice vote.
- e. **Hiring Approval for Youth Administrator.** Motion made by Supervisor Catching and seconded by Trustee Moore to approve the hiring of a youth administrator to replace

April Lopez, who has resigned and is moving out of state. Supervisor Catching said that an offer has been extended to a candidate. Trustee Reyna asked about the response to the job posting. Catching replied that several strong candidates applied and were interviewed. Motion passed by unanimous voice vote.
