A meeting of the Aurora Township Board of Trustees was held at the Aurora Township office, 80 North Broadway, Aurora, IL, at 4 p.m. on Thursday, June 23, 2016. Notice was sent to all members of the Board as required by statute.

Aurora Township Supervisor Bill Catching called the meeting to order at 4:00 p.m. Supervisor Catching led the group in the Pledge of Allegiance. Trustee Hicks gave the invocation.

- II. Motion to approve the minutes of the public hearing held on June 9, 2016 made by Supervisor Catching, seconded by Trustee Reyna. Motion carried by unanimous voice vote.
- III. Motion to approve the minutes of the regular board meeting held on June 9, 2016 made by Supervisor Catching, seconded by Trustee Hicks. Motion carried by unanimous voice vote.

# IV. Approval and/or Audit of Township and Road District Bills.

- a. Motion made by Supervisor Catching and seconded by Trustee Moore to approve the Town Fund bills in the amount of \$37,587.10. Motion passed by unanimous voice vote.
- b. Motion made by Supervisor Catching and seconded by Trustee Wells to approve the Road & Bridge Fund bills in the amount of \$29,234.96. Motion passed by unanimous voice vote.

# V. Reports

- a. **Assessor's Report** Report attached. Summary: The Assessor's books were delivered to the Kane County Supervisor of Assessments Office on Wednesday, June 15, 2016.
- b. **Highway Commissioner's Report** John Shoemaker. Summary: Resurfacing program is completed. Shouldering and Summit Avenue drainage project will begin soon.
- c. Supervisor's Report Bill Catching. Summary: Supervisor Catching reported that bill to rename the downtown Aurora Post Office after the late Township Clerk Ken Christy has passed both the U.S. Senate and House of Representatives and awaits the signature of the President of the United States. Catching thanked Trustee Hicks and Trustee Wells for their help at the 5Bs BBQ Fundraiser for the Township Youth and Senior Foundation on Monday. He said 253 meals were served, which is below the hoped for number, but he still considered the event a success. Catching also provided the Board a copy of the letter sent to all unincorporated residents regarding electrical aggregation. (Attached.)

The letter recommends that the residents switch back to ComEd as their electrical supplier. The township's aggregation consultant Progressive Energy will monitor the rates and make another recommendation near the end of the year if circumstances change.

- d. Code Enforcement Officer's Report Clarence Robinson. Report attached. Summary: Mr. Robinson said that the activities in the report are standard complaints. Mr. Robinson reported that he spoke with a resident about their uncut lawn and when they said they couldn't find anyone to cut it, he handed them a card for the lawn service used regularly by the Township on short notice. Mr. Robinson also complimented the Highway Department on their handling of the senior lawn program.
- e. General Assistance Manager's Report Suely Cabral. Report attached. Summary: Ms. Cabral reported that 12 clients were re-approved for financial assistance, two new clients were added and five clients were terminated. Ms. Cabral also reported that three new clients were approved for rental assistance under the Emergency Assistance program. Ms. Cabral mentioned that the seniors enjoy the social hour, with 25-30 seniors attending the event.

Trustee Hicks reported that the "Kids in Boats" event was a success. Trustee Hicks said that 15 volunteers helped the 50 kids who attended. Trustee Hicks said that many of the kids went out on the kayaks 10 or more times with one child claiming it was "the best thing I've ever done in my life." Trustee Hicks said that even one of the senior citizens who attended climbed into a kayak. Trustee Hicks thanked her daughter Peggy Hicks for her efforts to recruit kids for the event and said that the volunteers had so much fun they were ready for another kayaking event later this summer. Trustee Wells and Trustee Hicks asked Supervisor Catching to send in a couple of photos from the event to Township Officials of Illinois' *Perspective* magazine.

Trustee Wells and Trustee Hicks are putting together groups to go to the Senior Expo in August 2016. They will be asking for use of the Township bus for the event.
