Trustee Wells thanked the board for addressing and passing the snow removal program for seniors and the disabled; Trustee Hernandez raised several questions on the \$525,000.00 allocation for Senior Services. Those questions included, as to whether the Board would consider giving residents a rebate of 2.1% of Consumer Price Index; Does the Township provide insurance benefits to any of its retired employees; She asked Assessor Offutt if the evaluations of township properties were up or down for the year, and if so how much; Can the Board compare this year's financial statements to last year's and prior years financial budgets; Can the board do some projections on the numbers to see how the Township can save tax dollars (i.e. a 10% decrease in all of the township departments budget) Trustee Hicks stated the \$525,000.00 will be appropriated in the right way; Trustee Moore stated that a meeting of all local government leaders should be called in order to address the issue of tax increases.

XI. Public Comments

Resident George Scowins raised concerns with regard to the 1.2% levy increase. He stated that this increase along with other tax increases is making it more difficult for him to reside in the Township since he is on a fixed income. Resident Annette Johnson stated that in general, Government needs to live within its own means, without referendums. She stated the East Aurora School District is rebating money back to taxpayers for recent referendums passed.
