# II. APPROVAL OF THE MINUTES OF THE BOARD OF TRUSTEES MEETING ON APRIL 8, 2008

1. There was a motion by Trustee Silva and seconded by Trustee Craig to approve the regular meeting minutes of April 8, 2008. Motion passed by voice vote.

## III. APPROVAL AND/OR AUDIT OF TOWNSHIP AND ROAD DISTRICT BILLS

- 1. There was a motion by Trustee Craig and seconded by Trustee Campos to approve Town bills in the amount of \$37,398.09. Trustee Craig inquired on the current status of the month to month agreement with Human Resource Management Systems. Supervisor Murphy explained that the current assignment of Staff training was nearly complete. After discussion and clarification of other line items, motion carried by voice vote.
- 2. There was a motion by Trustee Craig and seconded by Trustee Silva to audit Road & bridge bills of \$35,997.92. Supervisor Murphy inquired about the Aurora Area Springs bill and the Patten Industries bill: Commissioner Burgess explained the springs on Truck 10 were replaced And the shop generator was repaired. Trustee Silva inquired about the Menards and Sam's Club bills: Commissioner Burgess explained, Menards was a "slop sink" for the shop and Sam's Club was toliet paper. Motion carried with voice vote.
- 3. There was a motion by Trustee Craig and seconded by Trustee Campos to audit General Assistance bills of \$4212.53. Motion carried by voice vote.
- 4. There was a motion by Trustee Craig and seconded by Trustee Silva to audit and approve IMRF \$5850.44, Social Security \$4367.25, R&B Social Security \$ 1007.04, and R&B IMRF 1527.64. Motion carried by voice vote.
