### MINUTES OF THURSDAY, DECEMBER 10, 2020 BOARD OF TRUSTEES MEETING

- I. Township Supervisor Bill Catching called the virtual meeting to order at 4:12pm Highway Commissioner Juan Reyna then led the Board in the Pledge of Allegiance. Township Clerk Thomas called the roll with the following Board of Trustees members present, Brenda Hernandez, Dolores Hicks, David Moore, and Juanita Wells. Also present: Highway Commissioner Juan Reyna. Staff Present: Patty Richardson (Chief of Staff). Absent: Davis Offutt (excused).
- II. Trustee Hicks led the Board in the invocation.
- III. APPROVAL OF THE MINUTES OF THE REGULAR BOARD OF TRUSTEES MEETING ON NOVEMBER 12, 2020.

There was a motion by Supervisor Catching and seconded by Trustee Wells to approve the Board of Trustee regular meeting minutes from November 12, 2020 as presented. The motion carried by voice vote.

There was a motion by Supervisor Catching and seconded by Trustee Moore to approve/audit Township and Road District Bills. The bills are as follows:

- 4. Patty Richardson advised the Board the Township that she submitted for reimbursement from Kane County for expenses related to COVID-19 that were incurred by the Township.

There was a motion by Supervisor Catching and seconded by Trustee

Hicks to approve Resolution 2020-37 Senior Grant Funding. The motion carried by a roll call vote, 5 Yes 0 NO.

#### VIII. BOARD MEMBER COMMENTS

Trustee Wells announced that the Salvation Army is collecting toys and other items to distribute for the holidays.

Trustee Hicks mentioned that she continues work with the senior community.
