## MINUTES OF THURSDAY, MAY 13, 2021 BOARD OF TRUSTEES MEETING.

- I. Township Supervisor Bill Catching called the meeting to order at 4:00pm and then led the Board in the Pledge of Allegiance. Township Clerk Thomas called the roll with the following Board of Trustees members present, Brenda Hernandez, Dolores Hicks, David Moore, and Juanita Wells. Also, present: Highway Commissioner Juan Reyna. Staff Present: Patty Richardson (Chief of Staff) and Jason Owens (Highway Department). Absent: Assessor Davis Offutt (excused)
- II. Trustee Hicks led the Board in the invocation.

# III. APPROVAL OF THE MINUTES OF THE REGULAR BOARD OF TRUSTEES MEETING ON APRIL 13, 2021.

There was a motion by Supervisor Catching and seconded by Trustee Wells to approve the Board of Trustee regular meeting minutes from April 13, 2021. The motion passed by a voice vote: 5 YES 0 NO.

# IV. APPROVAL AND/OR AUDIT OF TOWNSHIP AND ROAD DISTRICT BILLS

There was a motion by Supervisor Catching and seconded by Trustee Moore to approve/audit Township and Road District Bills. The bills are as follows:

- 3. Chief of Staff Patty Richardson advised the Board that the budget hearing has been moved to Thursday, June 10<sup>th</sup> at 3:30pm. She also mentioned that the Township's property tax distribution will be arriving soon.

There was a motion by Supervisor Catching and seconded by Trustee Hicks to approve Resolution 2021-07 Intergovernmental Agreement between Aurora Township and Aurora Township Road District for Senior Mowing Services-2021. The motion carried by a voice vote: 5 Yes 0 NO.

There was a motion by Supervisor Catching and seconded by Trustee Wells to approve the Request for IMRF Benefit Protection Leave, IMRF Form 6.32. The motion carried by a voice vote: 5 YES 0 NO.

Supervisor Catching and Trustee Moore led the Board in a discussion regarding the exterior improvements at the Township's Youth & Community Center.

## VIII. BOARD MEMBER COMMENTS

Supervisor Catching acknowledged that today's Board meeting would be the last meeting of the existing Township Board. He thanked everyone for their service and wished the departing members well in their future endeavors.

Trustee Moore thanked Kane County Sheriff Ron Hain for his work with the County's drug program.

Outgoing Clerk Thomas thanked the Board for appointing him to complete the unexpired term of the former Township Clerk now Kane County Judge Reginald Campbell.

Outgoing Trustee Hernandez expressed her appreciation to the Board and the residents of Aurora Township for allowing her to serve as a Township Trustee.

Trustee Wells raised a concern regarding the Ride-In-Kane Program failing to drop off local residents to work on time.
