GRANT FUNDING FOR 2022-2023 FISCAL YEAR**

WHEREAS, Aurora Township (the “Township”) desires to support organizations that help senior citizens to remain independent and those that serve at-risk children; and

WHEREAS, the Township has a long history of partnering with Senior Services Associates, Inc., to support their work with senior citizens in the township and at their senior center, now at 2111 Plum Street, Aurora; and

WHEREAS, the Township desires to continue to partner with Living Daylight Organization to support a summer STEM camp for 100 at-risk children in Aurora Township; and

WHEREAS, the Township desires to continue to partner with the Visiting Nurse’s Association to support health care services for residents of Aurora Township without health insurance; and


WHEREAS, the Township desires to continue to partner with Rebuilding Together Aurora to support its current Safe at Home program for accessibility modifications and safety-related repairs for income-qualified residents in the unincorporated areas of Aurora Township; and

WHEREAS, the Township seeks to continue to partner with The Neighbor Project (formerly known as the Joseph Corporation) to support their major home repair and credit counseling services in the unincorporated areas of Aurora Township.

NOW, THEREFORE, BE IT RESOLVED that the Board of Trustees authorizes the following grants: \$15,000 to Senior Services Associates, \$12,500 to Living Daylight Organization, \$10,000 to the Visiting Nurse's Association, \$10,000 to The Neighbor Project, and \$5,000 to Rebuilding Together Aurora.

FURTHER BE IT RESOLVED that funding for the Visiting Nurse's Association shall come from the General Assistance Fund.




