

NOW, THEREFORE, BE IT RESOLVED THAT the Board of Trustees of Aurora Township will hold its regular board meetings on the second and fourth Thursdays of each month in 2024 (except April and November) at 4:00 p.m. at the Aurora Township Main Office located at 80 N. Broadway, Aurora, Illinois. In April 2024, the regular meeting will be held on Tuesday, April 9, 2024, at 5:00 p.m. at the Aurora Township Youth and Community Center, 313 Gale Street, Aurora, Illinois. In November 2024, the regular meeting will be held on Thursday, November 14, 2024, at 4:00 p.m.

IT IS FURTHER HEREBY RESOLVED THAT the Township Clerk shall cause notice of the above times and places of the regular meetings to be published in *The Aurora Beacon News* during the first week of January 2024. The Clerk shall also comply with Section 2.02 by posting a copy of said notice at the township's main office and mailing or faxing copies of the notice and schedule to any news medium that has filed a request for such notice.


IT IS FURTHER HEREBY RESOLVED THAT the attached Board Meeting Schedule for 2024 is hereby approved. Any future changes to the Board's regular meeting schedule shall be by motion of resolution of the Board, with posting of notice and notification to the news media by the Clerk, in accordance with the requirements of the Illinois Open Meetings Act.
