

TAX LEVY ORDINANCE

TOWNSHIP

ORDINANCE No. 2023-30

An ordinance levying taxes for all town purposes for Aurora Township, Kane County, Illinois, for the tax year 2023, collectable in 2024.

BE IT ORDAINED by the Board of Trustees of Aurora Township, Kane County, Illinois, as follows:

SECTION 1: That the sum of Four Million Five Hundred Fifty-two Thousand Nine Hundred Sixty-one Dollars (\$4,552,961.00) are hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as:

General Corporate Fund

Illinois Municipal Retirement Fund

Mental Health Fund

Social Security Fund

Senior Citizens Services Fund

Public Assistance Fund

for the year 2023.

SECTION 5: That this ordinance shall be in full force and effect after its adoption, as provided by law.


