

RESOLUTION NO. 2024-24
SETTING COMPENSATION OF TOWNSHIP OFFICIALS
FOR THE FOUR-YEAR TERM BEGINNING MAY 19, 2025
AURORA TOWNSHIP, KANE COUNTY, ILLINOIS

WHEREAS, according to 50 ILCS 145/2, the compensation of township officers shall be set by the township board at least 180 days before the beginning of the terms of office; and

WHEREAS, according to 60 ILCS 1/65-20, the compensation for the road district treasurer shall be fixed by the township board and shall not be less than \$100 or more than \$1,000 per year; and

WHEREAS, according to 605 ILCS 5/6-207, the compensation of the highway commissioner shall be fixed by the township board at an annual salary of not less than \$3,000 to be paid in equal monthly installments, or a per diem amount for each day he or she is necessarily employed in the discharge of official duties; and

WHEREAS, according to 35 ILCS 200/2-70, the compensation of the township assessor shall be set by the township board at the same time the board sets the compensation of its township supervisor.

NOW, THEREFORE , IT IS HEREBY DETERMINED AND RESOLVED by the Board of Trustees of Aurora Township that the compensation of the township officials for the four year term beginning May 19, 2025 and ending May 20, 2029 (January 1, 2026 – January 1, 2030 for assessor) shall be as follows:

The salaries for township officials shall be as follows:


- a) Township Supervisor shall receive compensation of \$93,470 annually
- b) Road District Treasurer shall receive compensation of \$996 annually
- c) Township Clerk shall receive compensation of \$15,756 annually
- d) Township Trustees shall receive compensation of \$9,156 annually
- e) Highway Commissioner shall receive compensation of \$85,072 annually
- f) Township Assessor shall receive compensation of \$101,660 annually

BE IT FURTHER RESOLVED that in addition to the compensation outlined above, the following township officials will receive the following benefits:


1. Group health, dental, and life insurance benefits will be available to Elected Officials, except Clerk and Trustees, on the same basis as full-time employees of the township. Eligible officials who accept insurance benefits will contribute to the monthly cost of such premiums on the same percentage basis as covered full-time employees. In the event the Clerk and Trustees wish to obtain group insurance coverage, the township shall contribute to the premium only in the amount that it contributes for single coverage. Any additional coverage desired by the Clerk or Trustees shall be paid for by the Clerk or Trustees.
2. Travel reimbursement will be available to elected officials on official business per the federal mileage reimbursement rate. Hotel rental and one meal will be paid for by the Township when travelling on official business. Official business is defined as attendance at township-related educational seminars and conferences as well as work-related site visits or inspections.

3. The Township Supervisor, Highway Commissioner and Township Assessor will have use of a township vehicle or be reimbursed for use of their personal vehicles for official business. All three shall have use of a cellular phone for official business.
4. All paid elected officials may participate in the Illinois Municipal Retirement Fund to the extent that they are eligible.
5. Commencing on May 18, 2026 and annually thereafter on the third Monday in May, the compensation set forth above shall be increased by the lesser of 3% or CPI based upon the Consumer Price Index All Urban Consumers (CPI-U) U.S. City Average All Items December – December Percentage Change.
 - a. The December 2025 CPI rate will be used when calculating the increase effective May 18, 2026.
 - b. The December 2026 CPI rate will be used when calculating the increase effective May 17, 2027.
 - c. The December 2027 CPI rate will be used when calculating the increase effective May 15, 2028.
