WHEREAS, Section 2.02 of the Illinois Open Meetings Act, 5 ILCS 120/2.02, requires public bodies to give public notice of the schedule of regular meetings at the beginning of each calendar year, listing the dates, times, and places of such meetings; and


WHEREAS, Section 2.03 of the Illinois Open Meetings Act, 5 ILCS 120/2.03, requires that public bodies make available at the beginning of each calendar year, a schedule of all its regular meetings for such calendar year, in addition to the notice required by Section 2.02;

NOW, THEREFORE, BE IT RESOLVED THAT the Board of Trustees of Aurora Township will hold its regular board meetings on the second and fourth Thursdays of each month in 2026 (except February, April, November and December) at 4:00 p.m. at the Aurora Township Main Office located at 80 N. Broadway, Aurora, Illinois. On February 10, 2026, the meeting will be held on a Tuesday because of a conflict with the holiday falling on Thursday. In April 2026, the regular meeting will be held on Tuesday, April 14, 2026, at 5:00 p.m. at the Aurora Township Youth and Community Center, 313 Gale Street, Aurora, Illinois. In November 2026, the regular meeting will be held on Thursday, November 19, 2026, at 4:00 p.m. In December 2026, the regular meetings will be held on Thursday, December 10, 2026 and Tuesday, December 22, 2026 at 4:00 p.m.

IT IS FURTHER HEREBY RESOLVED THAT the Township Clerk shall cause notice of the above times and places of the regular meetings to be published in *The Aurora Beacon News* during the first week of January 2026. The Clerk shall also comply with Section 2.02 by posting a copy of said notice at the township's main office and mailing or faxing copies of the notice and schedule to any news medium that has filed a request for such notice.


IT IS FURTHER HEREBY RESOLVED THAT the attached Board Meeting Schedule for 2026 is hereby approved. Any future changes to the Board's regular meeting schedule shall be by motion of resolution of the Board, with posting of notice and notification to the news media by the Clerk, in accordance with the requirements of the Illinois Open Meetings Act.
