**AN ORDINANCE AMENDING THE ANNUAL TOWNSHIP BUDGET AND APPROPRIATION
ORDINANCE-GENERAL ASSISTANCE FUND**

FOR THE FISCAL YEAR BEGINNING APRIL 1, 2025 AND ENDING MARCH 31, 2026

WHEREAS, Aurora Township, County of Kane, State of Illinois, adopted an Annual Budget and Appropriation Ordinance for the fiscal year beginning April 1, 2025 and ending March 31, 2026 on May 8, 2025; and

WHEREAS, Pursuant to 50 ILCS 330/3, the Township Board of Trustees may amend the annual budget and appropriation ordinance from time to time; and

WHEREAS, Unanticipated expenditures and operational needs have arisen during the current fiscal year requiring an increase in certain appropriations beyond the amounts originally adopted; and

WHEREAS, The Township Board of Trustees finds that sufficient funds are available to support such increases;

NOW, THEREFORE, BE IT ORDAINED by the Township Board of Trustees of the Aurora Township, County of Kane, State of Illinois, as follows:

SECTION 1: AMENDMENT OF APPROPRIATIONS

The Annual Budget and Appropriation Ordinance for the fiscal year beginning April 1, 2025 and ending March 31, 2026 is hereby amended as follows:

GENERAL ASSISTANCE FUND

SECTION 2: INCREASE IN TOTAL APPROPRIATIONS

The amendments set forth herein increase the total amount appropriated for the fiscal year as follows:

General Assistance Fund: Increase of	\$18,500
Total Increase to All Funds:	\$18,500

The amended total appropriations for the fiscal year shall not exceed available revenues and fund balances.
