AMENDED BOARD MEETING SCHEDULE FOR 2026

**WHEREAS**, Section 2.02 of the Illinois Open Meetings Act, 5 ILCS 120/2.02, requires public bodies to give public notice of the schedule of regular meetings at the beginning of each calendar year, listing the dates, times, and places of such meetings; and

**WHEREAS**, Section 2.03 of the Illinois Open Meetings Act, 5 ILCS 120/2.03, requires that public bodies make available at the beginning of each calendar year, a schedule of all its regular meetings for such calendar year, in addition to the notice required by Section 2.02;

**NOW, THEREFORE, BE IT RESOLVED THAT** the Board of Trustees of Aurora Township will hold its regular board meetings on the second and fourth Thursdays of each month in 2026 (except April, November and December) at 4:00 p.m. and at 5:00 p.m. beginning May 14, 2026, at the Aurora Township Main Office located at 80 N. Broadway, Aurora, Illinois. In November 2026, the regular meeting will be held on Thursday, November 19, 2026, at 5:00 p.m. In December 2026, the regular meetings will be held on Thursday, December 10, 2026, and Tuesday, December 22, 2026, at 5:00 p.m.

**IT IS FURTHER HEREBY RESOLVED THAT** the Township Clerk shall cause notice of the amendment to the times and places of the regular meetings to be published in *The Aurora Beacon News* at least 10 days prior to the effective date of the change. The Clerk shall also comply with Section 2.02 by posting a copy of said notice at the township's main office and mailing or faxing copies of the notice and schedule to any news medium that has filed a request for such notice.


